LEGISLATION

In other news, we have begun to file legislation and are working with constituents to support the iss matter most to House District 10. Regarding local legislation, Senator Nichols, Representative Spitz filed bills this last week to expand the Trinity Valley Community College Board of Directors, allowin to provide quality education at affordable rates to more students in Henderson County and through college's service area. Regarding statewide legislation and policy, I co-authored House Bill 623, whi defend traditional marriage and Texas' state sovereignty. Additionally, I co-authored House Bill 916 will protect our 2nd amendment rights and bring Texas in line with 44 other states by allowing for carry. I filed House Bill 1187, legislation that would rename a segment of US Highway 287 the "Chri and Chad Littlefield Highway." I am thankful for the attention that the media has brought to in Ellis County have known all along--Chris and Chad are Texas heroes. I'm busy studying and draf other local and statewide legislation.
