

HB 1 creates a \$250.7 billion twoyear budget, covering everything from education to business and economic development. As a member of Article II of the Appropriations Committee, I worked to secure \$84 billion for health and human services programs in Texas.

EDUCATION	• In the wake of the tragedy at Sante Fe High School, HB 1825/SB 2135 improves communication between law enforcement officials and school superintendents when addressing potentially dangerous students. This legislation will strengthen school safety in our community and across Texas.
JOBS	• The 78th Legislative Session established the Texas Military Value Revolving Loan Fund to offer a low-cost alternative for military communities to fund needed projects for either base redevelopment, or to enhance and protect active installations. HB 2119 will make this borrowing process more efficient, thus bringing more jobs to Military City, U.S.A., specifically Port San Antonio.
VETERANS	• HB 1351 protects the data of veterans and their families who have used services provided by the Texas Veterans Commission. This bill will assist Texas veterans by providing them with the services they need, without being subject to economic targeting or data mining for any purpose.
SENIOR CITIZENS	• As a member of Article II of the House Appropriations Committee, I worked to ensure \$140.9 million be allocated for Adult Protective Services in the 2020-2021 biennium. Included in HB 1 , this funding will add new caseworkers as well as salary increases for those caseworkers. This means the state will have more personnel to protect senior citizens from abuse, neglect, and exploitation.
