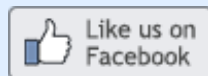
Thank you for subscribing to my newsletter. This edition contains important information about what is happening at the Texas Capitol during the second week of the 85th Legislative Session.

What's Going on in Austin?

House Budget Prioritizes Public Education

The initial 2018-19 budget introduced by Texas House leadership Tuesday puts additional resources into public education, child protection services and mental health while only increasing state spending by less than 1 percent from the last year.

The House is committed to producing a budget that is fiscally conservative while also meeting our commitments and obligations as a state, such as child protection, education and border security.

Highlights of the initial House budget include:

- **Public Education:** Provides funding to pay for expected enrollment growth of 165,000 students over the next two years. In addition, it includes \$1.5 billion for public education that is contingent upon the passage of legislation that reduces recapture and improves equity in the school finance system.
- **Child Protection:** Provides \$268 million to bring stability to the CPS workforce and reduce employee turnover, including the higher salaries and additional employees at CPS that were approved in late 2016 and recommended by Governor Abbott.
- **Mental Health:** Increases funding for behavioral health by \$162 million. This increased funding would help eliminate wait lists for mental health services and would improve services for Veterans with PTSD. This also funds the priorities of the House Committee on Mental Health, which focuses on early intervention, judicial training, and increased capacity.
- **Border Security:** Provides the \$663 million necessary to maintain the border security initiatives approved by the 84th Legislature, specifically hundreds of new state troopers along the border.

The initial House plan appropriates \$108.9 billion in General Purpose Revenue. For all Funds (Dedicated Revenue, Federal and Other Funds), the total budget would be \$221.3 billion. It reduces funding for administrative costs and discretionary programs across state agencies. It also eliminates one-time funding provided by the last Legislature, such as completed capital and information technology projects. It also includes cost-containment efforts to reduce spending in Medicaid by \$100 million.

The House took the first step towards producing a balanced budget that reflects their priorities while not increasing taxes or using money from the Rainy Day Fund, which is projected to have a balance of \$11.9 billion at the end of the next budget cycle.

In the Senate plan, Finance Committee Chair Jane Nelson would spend \$103.6 billion in state general purpose revenue over the next two years. Proposed expenditures include \$2.65 billion for state public education to cover enrollment growth in public schools and \$32 million more for high-quality pre-k programs. Other key line items include \$260 million to improve Child Protective Services; \$1 billion to address state hospital and mental health facility needs and \$63 million to clear the waitlist for community mental health services. The bill has some spending cuts as well, such as a 1.5 percent across the board spending reduction for all non-public education related expenditures.

Texas House Republican Caucus Re-elects Executive Board

Wednesday morning, the Texas House Republican Caucus (THRC) met to vote on an Executive Board. Members voted unanimously to re-elect the Executive Board of the House Republican Caucus for the 85th Legislative Session. Representative Tan Parker will serve as Chairman, Representative Cindy Burkett as Vice-Chairwoman, Representative John Raney as Secretary and Representative Dan Huberty as Treasurer.

We will play a critical role this session, and I pledge to use my background in business and public service to advance our conservative Republican initiatives during the 85th Legislature," said Chairman Tan Parker.

The Executive Committee develops long-range strategies to ensure the success of Republican Members of the House, oversees policy and communication for the Caucus, and works to accomplish the purpose for which the Caucus exists.

"We have worked to build a more powerful, cohesive Caucus that would enhance our majority position and ensure the resources necessary for us to be a more effective organization, stated Treasurer Dan Huberty. "Reflecting on the last four years, I can confidently say we accomplished those goals but know we cannot rest on past success for our future. We have built a strong fiscal base and a solid team to help deliver our positive conservative message during the 85th Legislative Session."

What's Happening in District 127?

Humble ISD Legislative Committee Update

On Thursday, Representative Huberty provided an update on the 85th Legislative Session. Huberty provided information on the budget numbers presented by both chambers this week and how they spend the dollars differently.

"The only bill we are constitutionally required to pass during a legislative session is a balanced budget," Huberty stated. "Right now there is a large gap between the House and Senate biennial budget numbers. It is our job to field the testimony and make changes to certain items then come together and work out the differences. It is hard work, but we have done it every session, or special session and we will do that again."

Rep. Huberty also laid out the priorities for the House, along with his own personal priorities for the session. The House will be focusing on Public Education and the fixing the finance system. "The House will also be looking to restore funding for disabled children's in-home therapy services; to repair the foster care system and Child Protective Services (CPS); to improve the State's mental healthcare safety net and to ensure that the Federal Government takes the brunt of costs of Border Security," said Rep. Huberty.

While laying out his own personal legislative priorities, Rep. Huberty talked much about public education and the possible changes and corrections that can be made for improvement. After the Texas Supreme Court ruled in 2016 that the current public school finance system was constitutional but should be reviewed by the legislature, Huberty has been studying the many possibilities to fix that system. He presented this as his number one priority item.

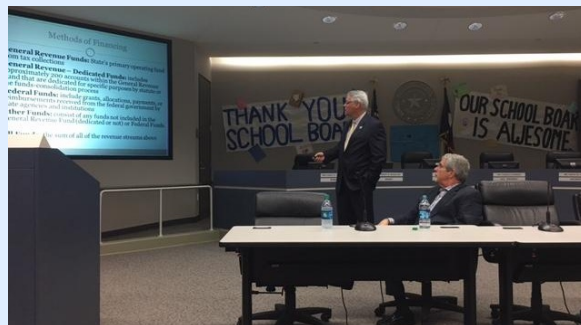
Rep. Huberty also discussed three specific bills he has already filed: **HB 966**, which would remove the expiration on Individual Graduation Committees (IGC) created by SB 149 in the 84th Session; **HB 357** would expand state-funded pre-k eligibility to the children of those who were severely injured or lost their life in the line of duty; and **HB 363**, which would prohibit the use of a monitoring system performance indicator based on the number or percentage of students receiving special education services.

At the close, Rep. Huberty and Dr. Guy Sconzo, the Executive Director of the Fast Growth School Coalition, took questions from the audience.
