STATE OF TEXAS HOUSE OF REPRESENTATIVES



Dear Friends and Neighbors,

The Texas Legislature has officially adjourned Sine Die following the 88th Regular Session and Governor Abbott has called several Special Sessions in 2023! I am proud to share this newsletter with you, which details many of our important victories that we accomplished for you.

When the Legislature convened in January, the state had a record-breaking amount of general revenue available - \$188.23 Billion, to be exact. This can be attributed to several factors such as the strength of the Texas economy, inflation due to the COVID-19 pandemic, and volatility in severance (oil and gas) tax collections due to the current global geopolitical climate and the war in Ukraine. However, at the end of the day, this budget surplus is YOUR taxpayer money. That's why I was proud to support SB 2 & 3 during the Second Special Session, which returns \$17.6 Billion in Property Tax Relief to Taxpayers (the LARGEST Tax Cut in Texas History)!

We passed a fiscally conservative budget totaling \$144.13 Billion for the 2024-2025 biennium, which remains under the Constitutional spending limit of population and inflation. The budget addressed many important items including:

- ★ \$5.1 Billion for Border Security (our largest investment in state history);
- ★ \$9.3 Billion to address infrastructure needs;
- ★ \$42.9 Billion for Public Health Funding; and
- ★ \$50.4 Billion to fully-fund Public Education.

This session, I was appointed by Speaker Phelan to serve on the House Criminal Jurisprudence Committee as *Vice Chairman* and appointed to serve as a member of the House Juvenile Justice & Family Issues and House Calendars Committees. The House Criminal Jurisprudence Committee considered legislation related to criminal law, probation, parole, and criminal procedures in our state's criminal courts. The House Juvenile Justice & Family Issues Committee considered legislation related to gang violence, youth correctional and rehabilitation facilities, criminal procedure related to juveniles in our criminal courts, and civil procedure in our family courts. The House Calendars Committee, a powerful procedural committee, sets the agenda for the legislative body by taking into account the priorities of the House as a whole and individual members.

Just a Bill, Sitting on Capitol Hill! This session, 8,046 bills were filed in the House and Senate. As you may remember from the Schoolhouse Rock episode, a bill must jump through many hurdles to become a law. A bill must be filed in either the House or Senate, be approved by a specific committee within its originating chamber, be adopted by the full membership of that chamber, and then repeat it all over again in the other Chamber! With 1,169 bills signed by Governor Abbott, the 88th Legislative Session had a bill passage rate of only 14.5%.

I am proud to share that I introduced 76 bills, passed 41 bills successfully out of the Texas House, and sent 25 total bills to the Governor's desk for signature...a bill passage rate of 33%!



STATE BUDGET



The 2024-2025 Budget totaled \$144.13 Billion for the 2024-2025 biennium, which remains under the Constitutional spending limit of population and inflation. Highlights of the state budget include:

- ★ \$17.6 Billion to Property Tax Relief (the highest in state history), including \$12.3 Billion in transfers to the Property Tax Relief Fund.
- ★ An additional \$5 Billion to fully-fund **Public Education** and an increase of \$3.2 Billion to the Foundation School Program (which is the primary source of state funding for public education).
- ★ An increase of \$1.4 Billion for **School Safety**, including grants to school districts and charter schools.
- ★ \$1.6 Billion for a 13th Check and \$3.4 Billion for a Cost-of-Living Adjustment (COLA) for Retired Teachers.

 Additionally, \$588.5 Million was appropriated to keep TRS health insurance premiums below 10% each year for TRS Active-Care participants.
- ★ \$5.1 Billion for Border Security and \$330 Million for grant programs to provide financial assistance to qualified sheriff, constable, and prosecutor's offices in rural counties.
- ★ \$5 Billion for the Texas Energy Fund to secure our electrical grid and construct, maintain, and modernize dispatchable (meaning, able to be deployed during severe weather emergencies) electric generating facilities.
- ★ \$1.5 Billion for **Broadband Development** to provide access to high-speed internet for all Texans.
- ★ \$1 Billion for the **Texas Water Fund** to shore up our state's water resources.
- ★ A \$5 Billion increase to **Transportation** for highway planning and design, right-of-way acquisition, and construction/maintenance of roads.
- ★ \$1 Billion for the Centennial Parks Conservation Fund to establish and maintain state parks.
- ★ \$625 Million for the Flood Infrastructure Fund at the Texas Water Development Board (TWDB).

PROPERTY TAX RELIEF

The government doesn't own your home – you do! Unfortunately, the most frequent concern I hear from constituents is that they are being taxed out of their homes. To me, that's just not right. During the second called special session, I was proud to support the LARGEST property tax cut in Texas history – totaling a record \$17.6 Billion! Additionally, our property tax relief bills, SB 2 and 3, raised the homestead exemption on school property taxes from \$40,000 to \$100,000, created a 3-year 20% appraisal cap pilot program for non-homesteaded property, and provided for savings on franchise taxes for approximately 67,000 small to medium-sized businesses.

ECONOMIC DEVELOPMENT

You don't become the ninth (soon to be eighth) largest economy in the world without strong economic policies. HB 5, the "Texas Jobs, Energy, Technology, & Innovation (JETI) Act, overhauled the previous "Chapter 313" program and creates an innovative, transparent economic development program to attract jobs, businesses, and economic development to our state through property tax abatements. HB 5012 created the Mansfield Qualified Hotel Project (QHP), which will allow the City of Mansfield to build a Convention Center, Hotel, & Entertainment District and use sales and hotel taxes to fund construction. To address current workforce shortages, HB 8 improved community college and workforce development funding formulas, HB 1859 created more paid apprenticeship opportunities through an alternative path to state licensure, and HB 3287 expanded funding to Texas State Technical College to fund job creation technical education (mechanics, plumbers, electricians, etc.) programs.

PUBLIC SAFETY & BORDER SECURITY

If we can learn anything from cities like San Francisco and Portland, it's that the rule of law *must* be respected in Texas. I was proud to author HB 17, which allows Texas residents to remove district attorneys who adopt or implement policies of refusing to prosecute crimes under current law. This bill was a top priority for Governor Abbott, Lt. Governor Patrick, & Speaker Phelan and I was honored to carry this critical public safety legislation. Fentanyl is wreaking havoc in our community, especially amongst our young people. HB 6 increases the criminal penalty for manufacturing or delivering the lethal drug, fentanyl, and allows for fentanyl poisonings to be prosecuted as murder. We must address the crisis at Texas' southern border. In addition to \$5.1 Billion appropriated for border security (our largest investment in state history), SB 1403 authorizes the Governor to execute an interstate border security compact, SB 1133 compensates landowners up to \$75,000 for property damage caused by illegal immigration, and SB 1900 designates drug cartels as foreign terrorist organizations.

PUBLIC EDUCATION & SCHOOL SAFETY

The Legislature maintained its commitment to retired teachers, to promote transparency for parents in relation to their child's education, to ensure our schools are safe, and to fully-fund public education. In addition to \$5 Billion new dollars appropriated to public education in our state's budget, SB 10 provided for a cost-of-living adjustment for retired teacher pensions. HB 1605 improved access to curriculum for parents, creates an opt-in program for school districts to use standardized materials, and establishes a mechanism for parents to trigger an audit of curriculum rigor. No child, teacher, or staff member should feel unsafe in our public schools - HB 3 required an armed security guard during school hours, required mental health first aid training for teachers, and appropriated \$15,000 to each campus to shore up safety and security measures. Additionally, HB 669 required installation of silent panic buttons in every Texas classroom.

FAMILY VALUES

Parents should be empowered to protect their children from materials which go against their values. HB 18, the "Securing Children Online through Parental Empowerment (SCOPE) Act" required parental consent and control over social media usage, HB 900, the "READER Act," kept sexually explicit books out of our public schools, and SB 12 restricted drag shows to adults-only. Additionally, SB 14 prohibited gender transitioning, reassignment, or dysphoria procedures or treatments on minors and SB 15 required collegiate athletes to compete in intercollegiate athletic competitions based on their biological sex.

PUBLIC HEALTH

Maintaining a healthy population is vital to our economy. The 88th Legislature made critical investment in our state's healthcare and insurance. HB 12 extended Medicaid eligibility to economically disadvantaged new mothers for the first twelve months postpartum and SB 379 exempts baby and feminine hygiene products from state sales tax. HB 1337 eliminated the use of "step therapy" by insurance companies, which requires patients to undergo a series of failed treatments before accessing healthcare recommended by their physician. HB 25 increased access and affordability to common prescription drugs and SB 490 required medical providers to send an itemized bill to patients before attempting to collect payment.

INFRASTRUCTURE

The future of our State depends on infrastructure developments made now. SB 2627 created the Texas Energy Fund to secure our electrical grid, HB 9 created the Broadband Infrastructure Fund to provide affordable and universal access to high-speed internet for all Texans, SB 28 created the Texas Water Fund to shore up our state's water resources, and Propositions 1 & 7 funding for the State Highway Fund were continued to provide for highway construction and maintenance. Finally, HB 718 banned the use of temporary (often fraudulent) paper tags, HB 3297 removed the arduous state requirement for yearly safety inspections for non-commercial vehicles, and SB 505 required electric vehicle owners to replace lost gas tax revenue through a flat registration fee to fund lost road construction and repair dollars.
